You have been given a summons to appear in the Houston Lake Municipal Division of the Circuit Court of Platte County, Missouri. Court is held in the Platte County Courthouse located at 328 Main Street, Platte City, Missouri. Please go to the Division One courtroom which is on the main floor of the courthouse.

You must appear in court on the date and time stated on the summons or make prior arrangements. Your failure to appear could result in a warrant being issued for your arrest, and could also cause the suspension of your driver's license and driving privileges.

If you intend to plead guilty to the charge as stated on the summons, you may sign your copy of the summons in the space provided on the back, and then remit the total of the fine and costs as shown on the schedule below. Mail your signed summons and the total amount due by certified check or money order (payable to "Platte County Circuit Court") to:
